the yearly exam and evaluation value. The Performance Guarantee should be valid for a period of 36 months. The Performance Guarantee shall be kept valid till completion of the project and Warranty period. The selected bidder shall be responsible for extending the validity date and claim period of the Performance Guarantee as and when it is due on account of non-completion of the project and Warranty period. In case the selected bidder fails to submit performance guarantee within the time stipulated, OJEE at its discretion may cancel the order placed on the selected bidder without giving any notice. OJEE shall invoke the performance guarantee in case the selected Vendor fails to discharge their contractual obligations during the period or OJEE incurs any loss due to Vendors negligence in carrying out the project implementation as per the agreed terms & conditions.
